



Prevention Plan Writing

- Involvement of the individual and guardian (as applies)
- Shared amongst appropriate providers
- Is not a means to an end
- Specific to the individual case and far reaching systems.
- May include technology adaptions
- Clearly states what the support is, why it is needed, and what is expected
- Ensure necessary resources are available
- Includes a responsible party





ICF Vaccine Requirements

Final Rule will take effect August 4, 2023 and will address the three specific COVID-19 mandates.

- **First-** the final rule withdraws the interim rule's requirement that all healthcare workers regulated by CMS be fully vaccinated.
- **Second-** The final rule permanently adopts policies requiring covered healthcare providers to continue to educate and offer COVID-19 vaccinations to staff and residents. This aligns with CMS approach for other infectious diseases (Influenza)
- **Third-** the final rule removes expired COVID-19 Testing requirements.





Thank you all for your exceptional services to individuals in Ashtabula County! July's DSP's of the month will be honored during August's Board meeting along with August's DSP's of the month.

- C. County Board and State Updates
 - a. Legislative & Budget Updates- Toni Scurpa- Governor Dewine signed the budget on July 3, 2023. This will affect funding for fiscal years 2024 and 2025. This is the largest investment made for the DD population. Agencies will begin to see increases in their funding beginning 1/1/24 and again on 7/1/24. For intermediate care facilities, they received their first increase on 7/1/23 and a second funding increase on 7/1/24. This funding will help providers be able to pay a competitive wage to their employees that will also include a \$1 increase/contribution made by County Boards. This will support an average DSP wage of \$18p/h starting 1/1/24 and \$19 p/h starting on 7/1/24. Intermediate Care facilities will also receive appropriated funding that will support their DSP wage of \$17 P/H on 7/1/23 and an increase to \$18 p/h on 7/1/24. Average wages are monitored through the wage verification survey for waiver providers, and through ICF cost reports for ICF's. - b. Strategic Planning updates and requests- Please use the link below to opt into being a part of the strategic planning process you can participate by being a part of focus groups or completing survey's as the are sent out. https://forms.gle/A57R8uLPVhXRDCsE6
- c. Prevention Plan Writing- James Kemmerle & Staci Long- Prevention plans are meant to be a joint/team process between the SSA, and the provider. Conversations should be initiated at the time of the incident, with the intention to have the same goal in mind, How to prevent from reoccurrence. SSA's will be setting a 2 week reminder prior to the closure date to make sure prevention plans have been discussed, and verification of changes and training has been completed. All these dates should be indicated on the form for your reference. Investigative Services and Support department rely on the SSA to share communications they have with the providers regarding prevention planning. Always reach out to the ISS department if you have questions regarding MUI/UI's and prevention plan writing.
- d. OhioISP Updates- (Access)- Ashtabula County Board of DD along with a small select amount of counties were able to start transitioning to the OHIO ISP earlier than most counties. Approximately 80% of our individual's ISP's should already have an active OHIO ISP. In the process of this transition there have been some snags that have made accessing the OHIO ISP not easy. If you have an individual that is receiving the Ohio ISP members of their team will receive emails that instruct you to click a link in order to view the ISP. At this time this link does not allow you to view the ISP, once all of the systems are connected correctly this will work. But at this time you can disregard that email. As long as you have access to Brittco you can access the OHIO ISP for the individuals that you support. You will see an OhioISP tab on the left side of your home screen when you log into Brittco. If you have any questions on how to access the OhioISP please reach out to Andrea Klimko and I will be happy to guide you through the process.
- e. ICF- Vaccine requirements- CMS vaccine requirements were released on June 5, 2023 and will be effective August 4, 2023. This Final Rule, Withdraws the vaccination requirements set forth in the IFR "OMNIBUS COVID-19 Health Care Staff Vaccination". Although this is not effective until August 4, CMS states they will no longer be enforcing the vaccination requirement effective immediately. This rule also adopts policies requiring covered healthcare providers to continue to educate and offer COVID-19 vaccinations to staff and residents. Keeping COVID aligned with other protocols for infectious diseases. Lastly the final rule removes expired COVID-19 testing requirements.
- f. RMN Annual Analysis Extensions- ICF's/DCs & CBs- Due to RMN reports not properly functioning correctly for portal users DODD is granting an

- extension to users complete their RMN annual Analysis. All 2022 Annual analysis will be due along with 2023 Annual Analysis on March 15, 2024
- g. DSP Compensation Survey due by July 16
- h. Retention Bonus submission-
- i. Pop in reviews occurring across Ohio- Day programs-ODH survey's- These survey's should be complete at this time. The Health and Human Services, Office of the Inspector General notified DODD of its intent to preform an audit of Adult Day Services providers to Ohio Medicaid recipients. These audits were completed as a pop in survey with little if any notification. These surveys were intended to review and assess the state processes and Ohio's compliance with regulations. We were informed that there were 20 Day programs that were chosen to receive an audit. While we are pretty sure these are complete please let us know at the county board if you have experienced this in the last month. If they do come through they are legitimate audits that are being conducted.
- j. Provider Training open classes-

Initial Staff Training- August 1, 2023- 8:30-4:30PM

Initial and annual staff training covers all the elements required by DODD for initial and annual training for your staff.

CPR/First Aid- August 7, 2023 9:00AM, 10:00AM, & 11:00AM

This course is a blended learning course with the majority of the coursework completed online and then a 1 hour in person skills session with a CPR certified instructor from NEON.

Medication Administration Initial Category 2- August 21, 2023 12:30- 4:30PM Medication Administration Initial Category 3 August 21, 2023 - 8:00- 12:00PM MUI/UI Refresher training- August 24, 2023- 9:00-11:30AM

You will receive a certificate that may be applied towards your annual training. Medication Administration Category 1 Initial Training (2 Days) September 25 & 26, 2023-8:00-4:00PM (both days)

- D. Resource Fair Highlights- Thank you to everyone that supported the provider resource fair either by attending or by having a table set up at the fair. This was truly an amazing event with over 200 people in attendance and 23 vendors on site. I could not have gotten this done without you all. Be on the look out to start planning for next year. I am looking forward to continuing to hold this resource fair every year.
- E. DSP Appreciation- September- It is hard to believe September will be here very soon. This year for DSP Appreciation we would like to host a luncheon for 1-2 providers a day onsite at your office or day program. We hope this will allow us more time to show our appreciation directly to the staff. I will be reaching out to all of you soon to discuss what dates and times work best for you.
